This course, GSS-1232: The Holocaust, Genocide and Human Rights, will be taught by a Pleasantville High School History teacher, but entails supervision by a Stockton faculty member, as well as a few common assessments. The program has been in existence for two years and continues to grow (please see attached syllabus). The students will have guest lecturers (both in school and on the Stockton campus), as well as the opportunity to engage in field trips, performances, and other related activities.

Upon successful completion, students with grades of a “C” or better, will receive 4 college credits from Stockton University. The high school courses are based on two Stockton classes: GSS-2240: The Holocaust and GAH-2114: Perspectives on Genocide. The Director of the Holocaust and Genocide Dual Credit consortium at Stockton University is responsible for overseeing the programs, providing mentoring for faculty and students, ensuring the integrity of the program, providing for common assessment, and offering a variety of opportunities for all involved.
