The Summer Institute is a three (3) day workshop designed to train staff members on the school wide implementation of the AVID program. Participants will learn strategies and techniques to empower students with the support needed to succeed in the most challenging classes. Teachers will be trained in WICOR Strategies during Summer Institute. AVID’s learning support structure for middle and high school—and enhanced for higher education—is known as WICOR, which incorporates teaching/learning methodologies in the following critical areas: Writing, Inquiry, Collaboration, Organization, and Reading to Learn. WICOR provides a learning model that faculty can use to guide students to comprehend materials and concepts, and articulate ideas, at increasingly complex levels (scaffolding) within developmental, general education and discipline-based curricula in their major.
