Approval of Minutes: February 4, 2010 and February 23, 2010, March 9, 2010

RESOLUTIONS/FINANCE:

It is recommended, that the Board of Education of the City of Pleasantville approve the following:

Finance Action Items to be approved at the March 23, 2010 meeting:

1. It is recommended, that the payments totaling **\$7,214,565.53** February 23 through March 23, 2010 be approved by the Board. The payments have been reviewed by the Business Administrator/Board Secretary.

4. Bilingual Consultants to provide Social History Reports-at **\$250.00** per report previously Board approved for Psychological/Learning Evaluation. Account #11-000-219-320-0000-400.
5. Resolution to approve Learning Through Life (LTL) is designed to teach children with special needs about the skills required to function more independently in life. LTL is also designed to educate and support school districts as they incorporate this method of learning into their curriculum for these children. LTL utilizes the skills of community members to bring real life learning experiences to children with disabilities aged 9-18.
