Pleasantville High School Prom Contract

The 2011 Pleasantville High School Students Prom will be held at the **Stockton Seaview Hotel** and **Golf Club** located at 401 South New York Road, Galloway, NJ on Friday, May 24, 2013 from 6:30 P.M. -11:30 P.M. Please review this contract with your son or daughter. We ask that you sign and return the attached release form at time of ticket purchase. Every Prom attendee and their parents must complete this form.

Requirements:

1. Students who plan to attend the Pleasantville High School Prom CAN NOT owe more than **two** outstanding detentions by May 17, 2013. Students who possess more than three detentions will be **EXCLUDED** from attending this event. Additionally, students who receive any **form of Suspension (ISS/ OSS)** during the week of the Prom will be barred from attending this event. In these and other instances where a student is found to be in violation of this contract, the student will be prohibited from entering the Prom and **NO**

REFUND WILL BE ISSUED.

2. All outstanding class dues must be paid in full for freshmen, sophomore, and junior Pleasantville High School students.

Curfew:

Prom doors open at 6:30 P.M. Prom doors close at 7:30 P.M.

No admissions will be allowed after 7:30 P.M. The prom ends at 11:30 P.M.

Violator's Consequences:

Students and/or their guests will not be allowed entry to the Prom or party.

PROM Attire:

1. PROM DRESS CODE – It is our desire to TRUST the youth and their parents to use their best judgment in the following guidelines set forth in choosing appropriate attire. We have loosely defined specific guidelines as follows:

a. Guys: Dress suits, sports coats, or tuxedos with dress shirts and ties.

b. <u>**Girls:**</u> <u>**Modest**</u>, non-provocative, non-revealing formal dresses with no extreme slits or short hemlines. Please be sensitive to the appearance of dresses that must be worn without bras. Wearing bras or built-in bras are recommended. Dresses that are short, extremely low cut, high cut or sheer will not be permitted.

- 2. Judgment about the appropriateness of any dress is given to school officials only. If there is any doubt about a dress, please have Ms. Potter, Sgt. Sims, or any school administrator check the dress out before prom night.
- 3. No bare feet allowed.

4. All handbags, backpacks and overnight bags will be subject to search upon check in.

Guest Expectations:

- 1. Students may bring guests between the ages of 15-21 to the Prom as their date. They assume full responsibility for their date's actions and will be required to leave with their date if this visitor is ejected.
- 2. Rules applying to Pleasantville High School students regarding conduct, attire, and curfew also apply to their dates or guests and underclassmen.
- 3. Pleasantville High School's administration reserves the right to refuse any individual. Administration will consider previous disciplinary infractions.

- 4. No one will be admitted to the Prom who has not signed a contract by May 10, 2013. <u>Students will not receive their tickets until a signed contract for themselves and any</u> <u>other outside guests is returned</u>. Do not have one date sign a contract and bring another date to the Prom. This date will be turned away.
- 5. All non-Pleasantville High School Prom dates must include with their contract document, a <u>clear photocopy</u> of a government issued ID with the Prom contract showing date of birth. (School I.D. card, State issued ID card, Driver's License, Passport, Military ID)

Conduct:

- Students are expected to attend the Prom sober: drug-free, alcohol-free and tobacco free. Upon arrival to the Prom, any student and their date suspected to be under the influence of an unknown substance will be subject to evaluation by a security/police officer.
- Anyone in attendance may be asked to empty his or her pockets or purses. Students and their dates are expected to comply upon the request of a school official or officer. Anyone refusing such inspection will be asked to leave the Prom.
- Anyone exhibiting unacceptable behavior as judged by school officials and/or officers (fighting, lewd dancing, smoking, foul language, etc.) will be asked to leave the Prom and **no refund administered.**
- No sexually inappropriate dancing, excessive grinding, or freak dancing allowed. Students engaging in this type of behavior will be escorted from the dance floor by school officials. Continued violation will lead to the student and their date being ejected from the prom.

Violator's Consequences:

If the above rules are violated, the following consequences will apply.

1. <u>Anyone</u> who violates the drug and alcohol policy will be ejected from the Prom. The student will be suspended from school for 4 days. Parents will be called to pick up their student and his/her guest within a reasonable amount of time. A police officer will transport students whose parents cannot be contacted or who do not arrive within a reasonable amount of time. The student may be ticketed for public intoxication or for being a minor in possession of drugs/alcohol. Dates of students who are ejected from the Prom and taking a ride with officers will call their parents so that someone can pick them up from a waiting area away from the main event.
